- d) To establish Association and Institutions in India with object of control, supervision, regulation and encouragement of the games of Football, Hockey, Cricket, Athletics and other Sports in India.

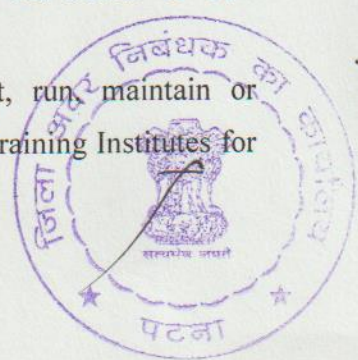

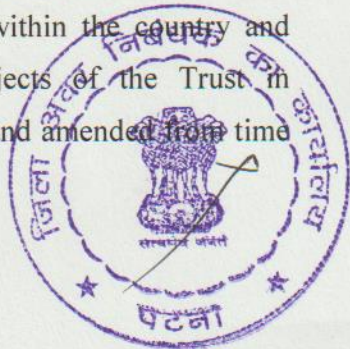

No Trustee shall have any personal claim on any movable and/or immovable properties of the Trust or make any profit whatsoever by virtue of his or her Trusteeship, provided that nothing herein shall prevent payment of any remuneration and/or allowance to any officer or to any employee of the Trust or to any Trustee of the Trust or to any other person for services actually rendered by them in connection with the aims and objects of the Trust.

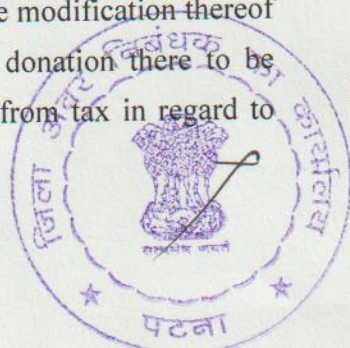

Procedure for 80G/ 12A Registration of NGO/ Charitable Trust/ Institution under Section 12A, Section 80G, which will facilitate the NGO/ Charitable Trust/ Institution to avail Income Tax exemption benefits.

In India, various incentives are available to NGOs / Charitable Trusts in the context of tax exemption. According to Section 11 of the Income Tax Act, 1961, NGOs enjoy various tax exemptions in respect of their income/ donations.

The Trust shall also accept the aid, donation and fund in shape of kind or cash from N.R.I. and Abroad Philanthropic Organization for the object of the Trust and it's undertake works and institution adopting legal process of general law and permission of the Government.

To establish any Pension Scheme on Funds, any Provident Fund or other funds for the benefit of the employees workers of the Trust and ex-employees and ex-workers and their dependents and relatives against the services rendered by the said persons for the purpose of fulfilment of the objects of the Trust.

ALL institutions established and administered by the foundation shall be Muslim Minority institutions within the meaning of Article 30 of the Constitution of India.

(i) To undertake projects, programmes and schemes relating to technical and professional education, scientific enquiry, and research and to establish, maintain and administer academic institutions as minority institution under Art 30 (1) of the Constitution of India for imparting Modern, Technical and Professional education to deserving youths.

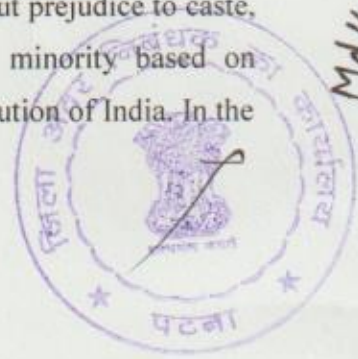

Sundar Ganj, P.S. Rasip, Dist- Aurangabad, (Bihar) Pin - 824102. Which are proposed to be established shortly after raising appropriate funds and all other institutions under its management and for achieving the aims and objects of the Trust.

6.00: RAISING OF FUNDS & EXPENDITURES:

a) for achieving any or all the objects of the Trust, the Trustees can raise funds through Donations, Grants and contributions and can also receive loans from Individuals, Firms, Institutions, Associations or Organizations and State/Central Government Agencies and shall have the right to invest and deal with the money and funds belonging to the Trust in such manner as may from time to time be determined by the Board of Trustees, subject to law of the land, and to take on lease or purchase or accept by way of gift any land, building or any other movable or immovable property, and remunerate any person or firm for services rendered to the Trust in any capacity and pay out of the funds of the Trust all costs, charges, expenses incidental to the establishment, registration and advertisements of this Trust and to adopt and take other means as may be incidental and conducive to the accomplishment of all or any of the objects of the Trust and shall also receive Loans, Grants and Donations from Foreign Governments, Institutions or Agencies and Individuals in accordance with the prevailing law of the land, and also to receive loans from Banks or other Financial Institutions for the benefit of the Trust.
